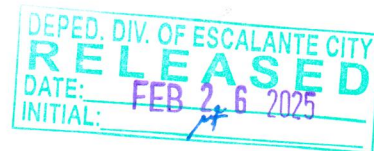

**CONDUCT OF THE E-RUNT POST-TEST FOR SCHOOL YEAR 2024-2025**

- The Schools Division of Escalante City, through the Curriculum Implementation Division (CID) will conduct the **Enhanced-Regional Unified Numeracy Test (E-RUNT) Post-Test** for Grade 1 to Grade 11 learners on **March 3-4, 2025**.
- To ensure non-disruption of teaching-learning activities, the E-RUNT will be conducted during the NMP time for Grade 1 to 10. For Grade 11, it will be conducted during the Independent Learning session.
- The main objective of this numeracy assessment is to determine the numeracy level and to profile the learners of the public schools across grade levels (Grades 1-11) for the implementation of immediate and appropriate intervention program/s.
- To align the learners' numeracy level with the Assessment Scale provided in DepEd Order no. 24, s. 2022 titled Adoption of the Basic Education Development Plan 2030 and to the Regional Education Development Plan (REDP), the Regional Office replaces the numeracy level to Proficiency Level in Numeracy following the scale below:

- There will be a monitoring team from the division office who will observe the conduct of the test. The monitoring tool on the conduct of E-RUNT is enclosed in this Memorandum.
- The deadline of the submission of E-RUNT Post-Test Result will be on **March 17, 2025**.
- School heads are expected to ensure the authenticity of the assessment results. They shall guarantee that the results accurately reflect learners' true knowledge and abilities, without being influenced by cheating, manipulation, or unfair advantages that

may compromise the fairness and authenticity of the test results.

8. E-RUNT results are not intended for ranking the schools but rather for specific school interventions and initiatives to improve learners' numeracy skills.
9. It is understood that in the conduct of this activity, there shall be no discrimination on account of age, gender, civil status, disability, religion, or other similar factors/personal circumstances that run counter to the principles of equal opportunity.
10. Expenses relative to the conduct of the test will be charged against Local Funds/MOOE Funds subject to the usual accounting and auditing rules and regulations.

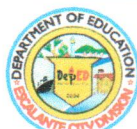

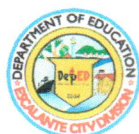
