RELEASE OF RESULTS FOR THE SPECIAL PHILIPPINE EDUCATIONAL PLACEMENT TEST (PEPT) ADMINISTERED ON OCTOBER 13, 2024

1. In line with the Department of Education (DepEd) Order No. 34, s. 2024, which outlines the guidelines for the administration of the Philippine Educational Placement Test (PEPT) to ensure the validation of learning experiences outside the formal school system, the Division of Escalante City hereby releases the official results of the Special PEPT conducted on October 13, 2024 (See Annex 1).
2. The PEPT serves as an alternative pathway for learners who wish to re-enter the formal education system by assessing their academic competencies equivalent to grade levels. The administration of the Special PEPT was undertaken to accommodate learners who were unable to take the regular PEPT due to valid reasons.
3. School heads are advised to disseminate the results to concerned learners and facilitate their appropriate grade placement or eligibility for further education in accordance with the provisions of DepEd Order No. 34, s. 2024. Schools are also directed to extend necessary support and guidance to the qualifiers, ensuring smooth reintegration into the formal education system.
4. The Division Testing Coordinator will require schools to identify their learners by writing the name of the school in the column provided in the sheet that can be accessed through this link: https://bit.ly/SpecialPEPT_Passers. Schools are advised to accomplish this task promptly to facilitate proper documentation and placement. For any inquiries, you may contact the Division Testing Coordinator.

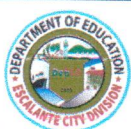
