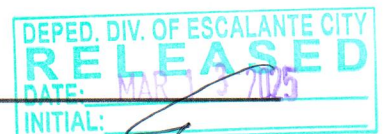



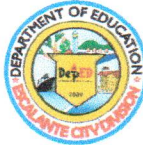

On the other hand, non-teaching staff shall be entitled to **Compensatory Time-off (CTO)** as per **Civil Service and the Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004** (Non-Monetary Remuneration for overtime service rendered).
