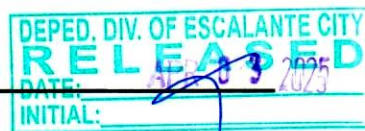

DIVISION ORIENTATION ON DEPED ORDER NO. 003 s. 2025 GUIDELINES ON THE IMPLEMENTATION OF QUALITY-ASSURED ASSESSMENT FOR THE NATIONAL CERTIFICATION OF LEARNERS IN THE SENIOR HIGH SCHOOL TECHNICAL-VOCTIONAL-LIVELIHOOD TRACK AND EXPANSION OF THE NUMBER OF COMPETENCY ASSESSORS

1. In view of the issuance of DepEd Order No. 3 s. 2025 titled "Guidelines on the Implementation of Quality-Assured Assessment for the National Certification of Learners in the Senior High School Technical-Vocational-Livelihood Track and Expansion of the Number of Competency Assessors the Schools Division of Escalante City, through the Curriculum Implementation Division shall conduct an orientation of all Public and Private Secondary Schools in the Division on **April 8, 2025 at the CID Office, of SDO Escalante City 8:00 AM - 12:00 NN.**
2. The activity shall focus on:
 - a. the process of availing the free assessment from the Technical Education and Skills Development Authority (TESDA) for SHS-TVL and;
 - b. free accreditation of teaching and non-teaching personnel from public and private schools as Technical Vocational Education and Training (TVET) Competency Assessors.
3. The participants of this activity are the School Heads of public and private Secondary schools of the Division.
4. The travel expenses incurred relative to the conduct of this activity shall be charged against school MOOE/other funds subject to the usual accounting and auditing rules and regulations.
