**CONDUCT OF FIELD TESTING OF THE DIGITAL-OFFLINE CONTEXTUALIZED WORD  
RECOGNITION AND STORYTELLING MATERIALS FOR GRADE 3 LEARNERS**

This office through the Curriculum Implementation Division informs the field on the conduct of field testing of the teacher-developed digital-offline contextualized word recognition and storytelling materials for Grade 3 learners, on April 10-11, 2025. This is part of our continuing efforts to enhance the quality and effectiveness of classroom instruction through contextualized and localized learning and teaching resources and supplementary instructional materials.
