**LEARNERS WITH SPECIAL EDUCATIONAL NEEDS (LSENS) MEDICAL  
EVALUATION AND ASSESSMENT**

1. Pursuant to Republic Act 11650, also known as the "Act of Instituting a Policy Inclusion and Services for Learners with Disabilities in Support of Inclusive Education", this law aims to provide support services to our learners with Special Educational Needs (LSENS) both males and females which are vital to provide the child an opportunity to demonstrate academic knowledge, skill, and understanding.

2. In this regard, the schools with LIS tagging for the year 2024 are required to submit list of LSENS to have medical evaluation and assessment if needed and the deadline will be **April 11, 2025 (Friday)**. The medical evaluation and assessment will be conducted through a Development-Behavioral Pediatrician/Psychometrician adopted by Special Education (SPED) teachers to determine the pupil's yearly progress.
