The Program Support Fund shall be utilized for the **provision and distribution of learning resources** necessary for the Pilot Implementation of the Strengthened Senior High School (SSHS) Curriculum. Learning resources such as **Learning Exemplars, LAS/Worksheets, curated learning resources, and printed reference materials** are accessible through the link (<https://tinyurl.com/Strengthened-SSHS-LRs>) to further support teaching and learning delivery in SHS pilot schools.
3. All procurement activities shall follow the applicable procurement methods in accordance with Republic Act No. 9184 (Government Procurement Reform Act) and its Implementing Rules and Regulations, and/or Republic Act No. 12009 (New Government Procurement Act).
4. In line with the aforementioned guidelines, all School Heads of the **Strengthened Senior High School (SSHS) pilot implementers (Escalante National High School, Mabini National High School, and Floro T. Bongco Farm School)** are directed to submit their proposals detailing the specific learning resource needs based on their Grade 11 enrolment of their respective schools for consolidation and appropriate action at the Division level.
5. All funds must be obligated and disbursed **on or before December 31, 2025.**
6. Immediate and wide dissemination of this Memorandum is desired.

SUBJECT : GUIDELINES ON THE UTILIZATION OF PROGRAM SUPPORT FUNDS FOR LEARNING RESOURCES FOR THE PILOT IMPLEMENTATION OF THE STRENGTHENED SENIOR HIGH SCHOOL (SHS) CURRICULUM

DATE : November 20, 2025

1. This memorandum establishes guidelines for the release and use of the Program Support Funds (PSF) for providing and distributing learning resources (LRs) for the Pilot Implementation of Strengthened Senior High School (SHS) Curriculum. The resources include:
 - a. Lesson Exemplars (LEs) and Learning Activity Sheets/Worksheets (LASs),
 - b. Curated Learning Resources (LRs), and
 - c. Printed Reference Materials.The LEs, LASs, and curated LRs are available at <https://tinyurl.com/Strengthened-SHS-LRs>. The School Division Offices (SDOs) or pilot schools can decide which LRs to print to supplement teaching and learning processes.
2. A budget of **Ninety-Seven Million One Hundred Eighty-One Thousand Five Hundred Ninety-One and 20/100 Pesos (P97,181,591.20)** from the 2024 Basic Education Curriculum (BEC) Continuing Funds is allocated for SHS LRs for the school year 2025 – 2026, specifically for Grade 11 learners and teachers.
3. The PSF will be downloaded to all Regional Offices (ROs) and may be further downloaded to SDOs or pilot schools, as deemed applicable and cost-effective. These offices will manage the provision and distribution of materials, either through in-house printing or third-party printers, based on the number of learners and teachers per pilot school. Procured materials must be delivered directly to public pilot SHS schools.
4. The ROs, SDOs, or schools may use any applicable procurement method in accordance with Republic Act (RA) No. 9184 (Government Procurement Reform Act)

and its Implementing Rules and Regulations, and/or RA No. 12009 (New Government Procurement Act).

5. Funds must be used in accordance with existing budgeting, accounting, auditing, and procurement rules and regulations
6. If schools will resort to in-house printing, only non-teaching personnel or volunteers should be involved in printing and reproducing SHS LRs.
7. Any excess amount or resulting balance may be utilized for other expenses related to the implementation of programs/activities/projects (P/A/Ps) covered by this issuance, subject to existing budgeting, accounting, auditing, and procurement laws, rules, and regulations. For this purpose, "expenses related to the implementation of P/A/Ps" shall refer to initiatives that contribute to the specific outcome aligned with the objective of this issuance, particularly operational requirements or support services essential to program delivery. These may include:
 - a. Procurement of semi-expendable items (goods below the capitalization threshold of Php 50,000.00, which are items classified as 'Property, Plant, and Equipment (PPE), in accordance with COA Circular No. 2015-007);
 - b. Provision and distribution of Landas Career Guidance Toolkit; and
 - c. Other operational needs directly supporting the production of SSHS LRs.
7. All funds must be obligated and disbursed by **December 31, 2025**. The ROs or SDOs must ensure compliance with the Cash-Based Budgeting System stipulated in the Republic Act No. 11975 (FY 2024 General Appropriations Act (GAA)) and National Budget Circular NO. 592 s. 2024 (Guidelines on the Release of Funds for Fiscal Year (FY) 2024 dated January 2, 2024).
8. The Statement of Expenditures (SOEs) must be submitted by the Regional LR Supervisor or Supply Officer to the Bureau of Learning Resources-Learning Production Division (BLR-LRPD) via email (blr.lrpd@deped.gov.ph) on December 26, 2025.

10. BLR shall continuously gather feedback on fund utilization and procurement challenges through SOE submissions, field visits, and virtual consultations.


