1. The Schools Division of Escalante City, through the SGOD-School Management Monitoring and Evaluation section, announces the conduct of the **Fourth Quarter Division Program Implementation Review and Performance Assessment (DPIRPA) CY 2025 on January 19, 2026 at the Training Center, ECES Compound.**
2. As per Regional Memorandum No. 167, s. 2023, the following are the DPIRPA mechanisms to be implemented.
 - a. The CID and SGOD Chiefs and the AO V or the Budget Officer shall present the Office Quarter Accomplishments based on the WFP and the Performance Indicators in graphical, tabular, and textual PowerPoint Presentations for easy understanding in the delivery of data elements.

Each operating unit shall prepare the WFP-based Accomplishment Report with MOVs. The Internal M&E of each operating unit shall submit the accomplished reporting templates to the Division M&E Specialist/Coordinator.
 - c. During the DPIRPA Reporting proper, CID and SGOD Chiefs and the AO V or the Budget Officer shall present the Office Quarter Accomplishments. Each operating unit shall conduct plan adjustments based on the comments/feedbacks.
 - d. After DPIRPA, the Division M&E Coordinator shall prepare the DPIRPA Accomplishment Report.

4. Meals and other expenses related to this activity are chargeable against Division MOOE and other Local Funds subject to the usual accounting and auditing rules and regulations.
