**SUPREME ELEMENTARY LEARNER GOVERNMENT (SELG) AND SUPREME  
SECONDARY LEARNER GOVERNMENT (SSLG) ELECTIONS FOR S.Y. 2026-2027**

1. Relative to the Memorandum DM-OUOPS-2025-10-07908, titled "Learner Government (LG) Elections for School Year 2026-2027," and Regional Memorandum No. 037 s. 2026, this office through the School Governance and Operations Division-Youth Formation Section, informs all schools that the elections for the SELG and SSLG shall be conducted after the third quarter examination of SY 2025-2026, following the indicative schedules outlined below:

ACTIVITY	DATES
School-Based Elections	January 26-30; February 2-13, 2026
Division Federated Elections	February 24, 2026
Regional Federation Elections	March 9-27, 2026
National Federation Elections	To be announced in a separate Memorandum

2. Furthermore, pending the approval of the revised Constitution and By-Laws of the Learner Government Program (LGP), schools are advised to refer to the previously issued guidelines which may be accessed via:

3. To ensure optimal engagement of all learners, all School Heads, through their SELG/SSLG Advisers, are requested to provide technical assistance during the conduct of the elections. The Division Youth Formation Coordinator is expected to monitor the actual conduct of elections in schools which shall be coordinated to the concerned Schools Heads.

4. Private schools and other institutions offering the K-12 Basic Education Program are also encouraged to implement these learner government elections and appointment guidelines according to their philosophy, vision, and mission.

5. All expenses incurred relative to the conduct of all activities related to SELG and SSLG elections for School Year 2026-2027 shall be charged to Youth Formation Division Program Support Funds while traveling expenses are chargeable against School Maintenance and Other Operating Expenses (MOOE), local funds or other available funds subject to the usual accounting and auditing rules and regulations.

6. Activities such as but not limited to campaigns and elections shall be conducted in such a manner that classes and other school functions will not be disrupted.


