DISSEMINATION OF THE FULL IMPLEMENTATION OF STRENGTHENED SENIOR HIGH SCHOOL CURRICULUM IN SCHOOL YEAR 2026-2027

1. Relative to DepEd Order No. 017, s. 2026, titled "*Strengthened Senior High School Curriculum (SHS)*," the Schools Division of Escalante City hereby informs all public and private Senior High Schools within the Division of the full implementation of the Strengthened Senior High School (SSHS) Curriculum beginning School Year (SY) 2026–2027.
2. The SSHS Curriculum was anchored on the Department of Education's Five-Point Agenda, which aims to better prepare learners for higher education, employment, entrepreneurship, and middle-level skills development.
3. All School Heads are directed to ensure the proper dissemination of this policy to all teaching and non-teaching personnel and to undertake the necessary preparations for its effective implementation.
4. The implementation of the SSHS Curriculum shall be in accordance with the provisions of DepEd Order No. 017, s. 2026, which amends relevant provisions of DepEd Order No. 021, s. 2019 (Policy Guidelines on the K to 12 Basic Education Program) and DepEd Order No. 030, s. 2017 (Guidelines for Work Immersion). All issuances inconsistent with the provisions of the said Order are deemed amended, repealed, or rescinded accordingly.
5. Education Program Supervisors, Public Schools District Supervisors, and School Heads shall monitor compliance and provide the necessary technical assistance to ensure the smooth and effective implementation of the SSHS Curriculum.
