To All Prospective Bidders:

This Bid Bulletin is issued to further clarify certain provisions of the Technical Specifications for the Procurement of Satellite Internet Connectivity and Twelve (12) Months Subscription Services for Thirty-Four (34) Schools in the Division of Escalante City. This Bid Bulletin shall form an integral part of the Bidding Documents and shall be read in conjunction with Bid Bulletin No. 1 and all other related procurement documents.

**CLARIFICATIONS**

1. Residential Subscription. For avoidance of doubt, the term "Residential Subscription" appearing in the Technical Specifications refers solely to the commercially available subscription package designation used by the satellite internet service provider and shall not be construed as limiting the intended use of the service to residential or household applications.
2. Intended Use. The procurement is intended for the provision of fixed-location satellite internet connectivity services for thirty-four (34) public schools under the Schools Division of Escalante City. The subscription shall be installed and utilized for official school operations and educational activities.
3. Service Utilization. The required internet service shall support access to DepEd online systems, Microsoft 365 services, learning management platforms, videoconferencing applications, digital learning resources, administrative systems, and other authorized school-related internet activities.
4. Equivalent Services. Bidders may offer the specified subscription plan or an equivalent fixed-location satellite internet service, provided that all minimum technical requirements and performance specifications prescribed in the bidding documents and Bid Bulletin No. 1 are met or exceeded.

5. Bidder Authorization and Capability. To ensure the validity of the subscription service and the availability of technical support, the bidder shall be capable of legally supplying, activating, installing, provisioning, and supporting the offered satellite internet service. For purposes of post-qualification, the bidder may be required to submit documentary proof of such authority or capability, including but not limited to: manufacturer authorization, service provider authorization, reseller or distributor accreditation, dealer certification, partner accreditation, principal certification, or any equivalent document demonstrating authority to provide and support the offered service.

This requirement is intended solely to establish the bidder's authority and capability to legally provide, activate, install, and support the offered satellite internet service. It shall not be construed as requiring a specific brand, manufacturer, distributor, reseller, or service provider accreditation where equivalent documentary proof of authority and capability is available.

IMPORTANT NOTE: The foregoing clarifications do not amend the Approved Budget for the Contract (ABC), quantity, scope of work, delivery requirements, or minimum technical requirements of the project. The clarification on authorization does not create an additional restrictive eligibility requirement but merely clarifies the acceptable documentary proof that may be required during post-qualification to verify the bidder's authority and capability to provide and support the offered service.

All other provisions of the Bidding Documents not affected by this Bid Bulletin shall remain in full force and effect.
