Item Description

Original Provision

- 1. Satellite internet connectivity kit: Standard Kit Gen 3 v4
- 2. 12 months subscription of Residential (₱5,830.00/month) x 12 months

Clarification

- 1. Satellite internet connectivity kit: Standard Kit Gen 3 v4 or equivalent.
- 2. The Residential Subscription indicated in the Technical Specifications refers to a fixed-location satellite internet service subscription intended for official school connectivity requirements.

The subscription shall include the following minimum service requirements:

Download Speed: Up to 200 Mbps

Upload Speed: Up to 25 Mbps

Latency: 20 to 50 ms

Fixed-location satellite internet connectivity;

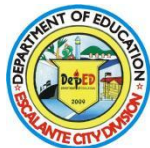
Continuous internet access for school operations;

No monthly data cap or equivalent unlimited data allocation during the subscription period;

Support access to DepEd online systems, Microsoft 365 services, learning management platforms, videoconferencing applications, and other official school-related internet activities;

Subscription activation and service provisioning;

Technical support during the contract period.
