**PREPARATORY MEETING ON THE IMPLEMENTATION
OF THE SCHOOL-BASED FEEDING PROGRAM (SBFP) FOR SY 2026-2027**

1. The Department of Education, SDO Escalante City through the School Governance and Operations Division - School Health and Nutrition Section informs the field that there will be a preparatory meeting on the implementation of the School-Based Feeding Program for SY 2026-2027 on **September 14, 2026 8:00AM - 5:00PM** at the **Gabriela Hall, Old SDO site**.
2. This quarterly meeting aims to address concerns and provide guidance on the implementation of the SBFP among schools to supplement the nutritional needs among learners from Kindergarten to Grade 6 through the provision of hot meals, nutritious food products (NFP), and pasteurized/sterilized milk in all public elementary schools, in accordance with Republic Act No. 11037, otherwise known as the **"Masustansyang Pagkain para sa Batang Pilipino Act."**
3. The participants in this activity are the 28 Elementary School Heads and 28 respective School-Based Feeding Program (SBFP) Coordinators, 6 School Health and Nutrition personnel and 11 SDO Section Heads.
4. Travel expenses to be incurred by the participants during the activity shall be charged against the School MOOE/Local Fund, while meals and snacks shall be charged against the SBFP Downloaded Funds, subject to the usual accounting and auditing rules and regulations.
